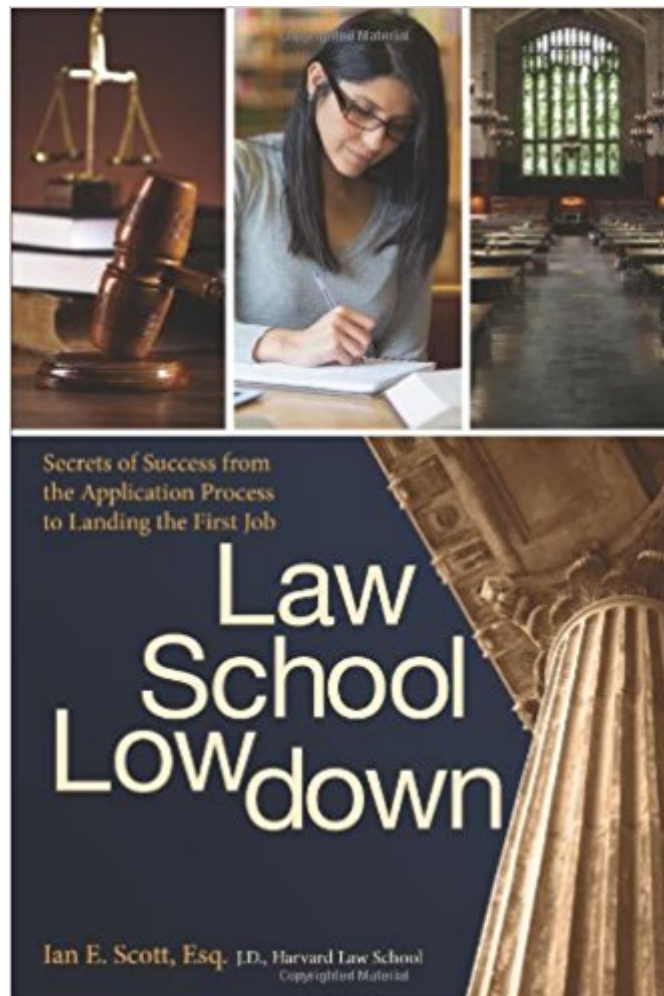

The book is a useful guide for law students and it contains a great deal of valuable information on how to put together the application and how to approach your law school studies. The author is a cheerleader for law schools and he urges people to attend. You can't blame him. He attended Harvard Law School and obviously had a positive experience. He does warn students that (a) there was negative press about law schools and their employment statistics recently and (b) that it can be tough to get a good job if you go to a low-ranked law school. Indeed, he urges students to work hard and graduate in the top third of the class. I can't disagree with his view on this issue. I would urge students to think about what you want to do with the law degree before you go to law school. The advice on the application is particularly good. I also agree with the author's approach - he urges students to work hard and try to get ahead in law school. He has good pointers for success in large firms and success as a summer associate. This is probably the most useful book in this area. For a view that is probably too negative, you can consider "Don't Go To Law School Unless" by Paul

Campos.Scott's book is a quality effort with solid advice for the prospective lawyer. The book is worth reading, especially if you dread the application process. There are helpful tips for every applicant.

While planting my first step toward law school, I was fortunate enough to come across this book--and I love it!
